### 2. Dispatch of Notice convening AGM

- i. Pursuant to General Circular No. 14/2020, 17/2020, 20/2020 and 02/2021, dated 8<sup>th</sup> April, 2020, 13<sup>th</sup> April, 2020, 5<sup>th</sup> May, 2020 and 13<sup>th</sup> January, 2021, respectively issued by the Ministry of Corporate Affairs, advertisement was published in "Free Press Gujarat" (English Newspaper) and "Lokmitra" (Vernacular language –Gujarati Newspaper) on 11.09.2021 respectively specifying the date and time of the AGM, availability of the notice on Company's Website, manner of registration of email IDs by the members (both physical and demat) who are yet to register their email ids with the company, manner of voting through remote e-voting or through e-voting system at the AGM etc.
- ii. The company hosted the notice of AGM on its website, website of the agency providing the Platform for remote e-voting and e-voting during the AGM.
- iii. The company informed that on the basis of the Register of Members and the list of Beneficial Owners made available by the Registrar of Share Transfer Agent ("RTA") of the company and depositories viz National Securities Depositories Limited ("NSDL") and Central Depository Services Limited ("CDSL") respectively, the company completed dispatch of Notice of AGM on 09.09.2021 by E-Mail as per the MCA Circular No. 17/2020 dated 13.04.2020 read with Circular No. 20/2020 dated 05.05.2020 to 1131 members who had already registered their e-mail IDs with the Company / Depositories;

### 3. Cut-Off date

### 4. Remote e-voting Process and Voting at the AGM

### i. Agency

The company appointed **Central Depository Services Limited ("CDSL")** as the agency for providing the platform for remote e-voting and e-voting during AGM.

### ii. Remote e-voting Process

Remote e-voting platform was open from Monday, 27<sup>th</sup> September, 2021, 09.00 a.m till Wednesday, 29<sup>th</sup> September, 2021, 05.00 p.m. and members were required to cast their votes electronically conveying their assent or dissent in respect of the resolutions on the remote e-voting platform provided by CSDL

- iii. As prescribed under Rule 20(4)(xiii) of the Companies (Management and Administration) Rules, 2014, for the purpose of ensuring that Members who have cast their votes through remote e-voting do not vote again during the general meeting, the scrutinizer shall have access after closure of period of remote e-voting and before the start of general meeting, to only such details relating to Members who have cast their votes through remote e-voting, such as their names, DP ID & Client ID / folios; number of shares held but not the manner in which they have voted.
- iv. Accordingly, CDSL, the remote e-voting agency provided us with the names, DP ID & Client ID / folios and shareholding of the members who had cast their votes through remote evoting.
